- 1. Carbon Emissions 2010/11
- 1.1 Key Issue for Decision
- 1.1.1 To consider the Council's carbon footprint for 2010/11 and the new way in which this is calculated and reported.
- 1.2 Recommendation of the Assistant Director of Regeneration and Cultural Services
- 1.2.1 That the Cabinet Member notes the reported figures for CO_2e emissions from the Council's operations during 2010/11 which indicate an 8.58% increase from 2009/10.
- 1.2.2 That the Cabinet Member notes the reasons behind the increase in emissions seen.
- 1.2.3 That the Cabinet Member approves and supports the publishing of the attached 'Greenhouse Gas Emissions from Local Authority Owned Estate and Operations' report, which outlines the greenhouse gas emissions from Maidstone Borough Council for 2009/10 and 2010/11, and conforms to the format requested by the Department of Energy and Climate Change.
- 1.3 Reasons for Recommendation

<u>Background</u>

- 1.3.1 This report presents the Council's carbon footprint for 2010/11 and compares it against the carbon footprint for 2009/10 and details progress against the Council's annual carbon reduction targets.
- 1.3.2 Further this report outlines the new way (following a change in guidance by the Department of Energy and Climate Change (DECC)) in which the council's carbon footprint is calculated and

represented, and the requests made by DECC with respect to reporting and publishing of relevant information.

Changes to Reporting Procedures

- 1.3.3 On the 13th April 2011, Gregory Barker MP, sent a letter to all Chief Executives of Councils in England outlining how Chris Huhne, Secretary of State for Energy and Climate Change, signed a Memorandum of Understanding (MOU) with the Local Government Group that recognised the pivotal role that local councils have in tackling climate change. This letter is attached in Appendix A.
- 1.3.4 Through DECC's support of the MOU they have requested that local councils measure and report their greenhouse gas emissions from their own estate and operations in accordance with the joint DECC & Defra guidance that was published in September 2009 (http://www.defra.gov.uk/publications/2011/03/26/ghg-guidance-pb13309/).
- 1.3.5 The measurement and reporting methods outlined in the guidance are based on the Greenhouse Gas (GHG) Protocol, the internationally recognised standard for the corporate accounting and reporting of GHG emissions. The most widely accepted approach to detailing the GHG emissions is to identify and categorise emissions-releasing activities into three groups, also known as scopes. The three scopes are:
 - Scope 1 (Direct emissions): Activities owned or controlled by your organisation that release emissions straight into the atmosphere e.g. emissions from combustion in owned or controlled boilers and vehicles;
 - Scope 2 (Energy indirect): Emissions being released into the atmosphere associated with your consumption of purchased electricity, heat, steam and cooling. These are indirect emissions that are a consequence of your organisations activities but which occur at sources you do not own or control; and,
 - <u>Scope 3 (Other indirect):</u> Emissions that are a consequence of your actions, which occur at sources which you do not own or control and which are not classed as Scope 2 emissions e.g. business travel by means not owned or controlled by the organisation and purchased materials or fuels.

Carbon dioxide produced from the combustion of biomass/biofuels should be reported separately to emissions in Scopes 1, 2 and 3.

- 1.3.6 Previously, emissions were split between stationary (i.e. all fuel / electricity usage at all buildings) and transport.
- 1.3.7 In addition, only the direct emissions were calculated. The new guidance also calculates the indirect emissions associated with the extraction and transportation of primary fuels as well as the refining, distribution, storage and retail of finished fuels. These are known as fuel cycle or well-to-tank emission factors, thereby enabling life-cycle emissions to be calculated. These associated indirect emissions are included under Scope 3 emissions.
- 1.3.8 The changes outlined above in the reporting methods mean that the footprints reported below, are difficult to compare with those presented previously. As such we have taken this new methodology and used a baseline year of 2008/09 (in-line with the Carbon Management Plan) and revised the targets to match this methodology for comparison purposes.

The Councils GHG Emissions for 2010/11

- 1.3.9 As discussed above, the GHG emissions presented in Table 1 have been calculated using the methodology and emission factors as set out in the DEFRA and DECC Guidance. The emissions are presented as absolute emissions, but the weather corrected emissions can be found in Appendix B for comparison. The emissions for 2009/10 and 2008/09 are also shown for comparison.
- 1.3.10 Table 1 compares the GHG emissions from 2010/11 with those for 2009/10, and 2008/09. It can be seen that the GHG emissions for 2010/11 were 6,101 tonnes CO_2e compared to 5,619 tonnes CO_2e in 2009/10 and 6,255 tonnes CO_2e in 2008/09. This equates to an 8.58% increase in emissions between 2009/10 and 2010/11.
- 1.3.11 During the period this figure was calculated, Mote Park Leisure Centre was undergoing a major refurbishment and was providing a reduced service. If the energy usage figures for 2009/10 were replaced with the figures for 2008/09 (a full year of usage) then the total annual emissions would have been 5,897 tonnes of CO_2e . This would mean that the emissions in 2010/11 were 3.46% higher than for 2009/10, as opposed to the 8.58% reported in 1.3.10. As such, even if allowances are made for the closure of Mote Park Leisure Centre, the emissions still increased.

1.3.12 For a detailed look at the reduction in emissions noted between 2008/09 and 2009/10 please refer to the background document noted in 1.8.5.

1.3.13 In terms of the individual scopes the yearly comparison between 2009/10 and 2010/11 is as follows:

Scope 1: 14.52% increaseScope 2: 0.97% increaseScope 3: 4.57% increase

- 1.3.14 In terms of the breakdown between scopes, Scope 1 emissions accounted for 55.2% of the total emissions for 2010/11, Scope 2 for 31.1% and Scope 3 for 13.7%.
- 1.3.15 Table 2 below shows the emissions breakdown within each scope of the main sources that make up each scope, and this has been done for 2008/09, 2009/10 and 2010/11.

Scope 1

- 1.3.16 The Scope 1 emissions are split in Table 2 between fuel consumption (specifically natural gas usage) in buildings and owned / controlled transport. It can be seen that the emissions from transport marginally increased but the main source of the increased emissions from this Scope are from the fuel consumption (natural gas) in buildings.
- 1.3.17 In 2009/10 Mote Park Leisure Centre was operating a much reduced service due to a major refurbishment that occurred, so it was expected that when a full service was resumed in 2010/11, that emissions from this building would increase, which was evidenced. However, there were significant increases in the emissions from other buildings as well, which are shown below in Table 3.

1.3.18 The table above clearly highlights that a number of the key buildings in the Maidstone Borough Council portfolio have

experienced a significant increase in emissions between 2009/10 and 2010/11. The most notable of these, both in the sense of the size of the emissions increase, and the size of the impact on the overall emissions are Vinters Park Crematorium, The Hazlitt Arts Centre and Maidstone House.

- 1.3.19 Vinters Park Crematorium underwent a refurbishment in late 2009, although the GHG emissions in 2009/10 were only marginally less than in 2008/09. In the first full year of operation post the refurbishment the emissions have increased by 38.82%. Additional equipment (in the form of mercury abatement kit) was installed in this refurbishment (thereby increasing the load) as well as more efficient cremators (reducing the number of cremators from 3 to 2). Investigations are underway to establish the cause of the increase (given there was no increase in the number of cremations).
- In the case of the Hazlitt Theatre and Maidstone House (and to some extent Vinters Park Crematorium) the large increase in usage is likely to have been caused in part by the severe winter that occurred in 2010/11 and the extra fuel used to maintain an acceptable temperature in the buildings. Furthermore, in the case of Maidstone House, the biomass boiler was being recommissioned over the winter period and is ongoing, and was therefore not able to provide a significant proportion of the heat for Maidstone House. It is planned that the continued work on this boiler is completed over the summer period, ready for the 2011/12 winter. It should also be noted that in the case of Maidstone House & Gateway, when this usage is broken down month by month, the main increase in usage compared to 2009/10 was seen in the months from April to October.
- 1.3.21 The weather corrected emissions in Appendix B indicate the effects of this harsh winter more clearly. Weather correction works by altering the emissions from natural gas usage based on the number of degree days experienced over the time period of the data. In 2009/10 there were 2206 degree days compared to 2414 in 2010/11. When these are considered and factored in, the difference in total annual emissions between 2009/10 and 2010/11 is 6.33% compared to 8.58% when this is not considered. As such, it can be seen that a proportion of the emissions increase experienced between 2009/10 and 2010/11 was due to the colder conditions experienced during that period.

Scope 2

1.3.22 The Scope 2 emissions include the electricity use at all Council owned or controlled buildings. When the emissions from 2009/10

and 2010/11 are compared, a small increase of 0.97% in emissions is seen.

1.3.23 There were some changes in emissions from electricity usage at a number of buildings and these are shown in Table 4 below.

- 1.3.24 It can be seen that there was a 10.03% increase in the electricity used at Maidstone House, and a 9.64% increase in the electricity used at Maidstone Gateway. It is thought that these increases are due to the fact that there were a large number of electric heaters used to heat the building during the winter months, when the usage peaked the most compared to 2009/10, as the temperature generated by the main heating did not reach an appropriate level for staff to work in.
- 1.3.25 The increase in electricity seen at the New Parkwood Depot was also expected as the depot only opened in December 2009 and as such was only operational for a quarter of the 2009/10 baseline but was fully operational in 2010/11.
- 1.3.26 Furthermore, the emissions from Cobtree Golf Course Club House reduced by a further 7.73%, following on from a 16.5% reduction between 2008/09 and 2009/10.

Scope 3

- 1.3.27 Table 2 shows that there was a small, 4.57% increase in Scope 3 emissions. This was predominately due to the increase in emissions associated with the extraction and transportation of primary fuels as well as the refining, distribution, storage and retail of finished fuels, which are associated with both Scope 1 and Scope 2 emissions.
- 1.3.28 It is also noted that the emissions associated with Business Mileage decreased by 9.57%.


Performance against Targets

1.3.29 In April 2011 Cabinet agreed the Carbon Management Plan which aims to reduce CO_2e emissions by 20% by March 2015, from a 2008/09 baseline. These targets were calculated based on a different methodology to that used to calculate the GHG emissions presented in this report. These targets have been superimposed onto this methodology and the progress against the Councils target is shown in both Table 5 and the graph below.

1.3.30 It can be seen that the emissions in 2009/10 were 6.76% below the designated target for that year. However, the increase in

- emissions experienced in 2010/11 means that actual performance was 5.08% over the target for that year.
- 1.3.31 It should be noted that if the weather corrected emissions are considered (see Appendix B) this shows a similar pattern, in that the targets for 2010/11 are missed, but these are only missed by 1.35%, which indicates further the effect the weather has had on the emissions from last year, when compared to years before.

Carbon Management Plan

- 1.3.32 The Carbon Management Plan which was adopted in April 2011, outlines the way in which the Council aims to reduce CO_2e emissions by 20% by March 2015, from a 2008/09 baseline, and embed carbon management into the organisation.
- 1.3.33 The Carbon Management Plan (CMP) sets out the projects aimed to reduce the Councils emissions, and through the implementation of the actions, the Council will continue to seek to reduce its emissions. The Carbon Management Team who worked to produce the CMP have set up a process for project identification which will be used to identify new opportunities, in addition to those already in the plan.
- 1.3.34 The CMP was in development during 2010/11 and the majority of actions have only just begun to be implemented / taken forward (as of May 2011), so the effects of these are yet to be seen.
- 1.3.35 The following projects are in the process of being planned / implemented and should all contribute towards reducing the amount of energy used by the Council.
- 1.3.36 In addition to the actions identified in the table , the areas where the greatest increases in emissions have been seen will be investigated on a site by site and source by source basis, to identify any specific problems and potential solutions as soon as possible.

Submission of Information to DECC

- 1.3.37 DECC is requesting that each local authority publishes its own GHG report locally on its own website by the end of July each year, and for this year, that data on the GHG emissions for both 2009/10 and 2010/11 is published. In addition, it has been requested that this information is emailed straight to DECC.
- 1.3.38 Attached in Appendix C is the proposed GHG Report for Maidstone Borough Council covering all the points which are recommended for inclusion.

Data Limitations

1.3.39 The limitations of using the collected data to establish a GHG Emissions report have been explained in previous carbon footprint reports. It should be re-iterated however that much of the data used in the report this has not been recorded for the specific purpose of compiling a carbon footprint and in some limited cases data has had to be estimated.

1.4 <u>Alternative Action and why not Recommended</u>

1.4.1 The Council could decide not to publish a GHG Report on the Council's website, nor submit the GHG Emissions data for 2009/10 or 2010/11 to DECC. However, such an approach is not recommended due to the reputational risk associated with not submitting information and making this publicly available.

1.5 <u>Impact on Corporate Objectives</u>

1.5.1 This decision is directly related to achieving the following Key Objectives from the Strategic Plan for 2011/12;

Priority: For Maidstone to be a decent place to live

Related Outcome: continues to be a clean and attractive environment for people who live in and visit the borough

Priority: Corporate and Customer Excellence

Related Outcome: the Council will continue to have value for money services that residents are satisfied with

1.6 <u>Risk Management</u>

1.6.1 The risk of not achieving reductions in the Council's GHG emissions in line with the targets in the Carbon Management Plan has been identified. This will be managed by implementing and maintaining a robust Carbon Management Plan which is able to link reductions to specific projects which will allow more effective and accurate monitoring and will also ensure that new projects are continually developed to make sure that momentum with the plan is not lost. Full implementation of the Carbon Management Plan began in May 2012. To enable the CMP to be successfully implemented, adequate resource will need to be put into the delivery and monitoring of the action plan.

1.6.2 The reputational risk associated with not achieving carbon reduction is being managed by maintaining a systematic and evidence based approach to carbon reduction settings, basing decisions on robust data and best practice, and setting challenging and measurable targets. The platform for this will be the Carbon Management Plan.

- 1.7.2 Financial: Greater CO₂ emissions have a financial consequence as the implication is that although the Council has in 2010/11 consumed greater amounts of energy, the overall cost was less due to fluctuations in and timing of changes in energy prices over the last 2 – 3 years. However, the projected energy price increases over the next few years show an upward trend, which will mean that unless the amount of energy consumed by the Council decreases, the Council will face an overall increase in its energy bill. This illustrates that there are environmental and financial pressures to reduce CO₂ emissions and energy consumption.
- 1.7.3 Environmental / Sustainable Development: This decision will increase the Council's ability to deliver improved environmental performance from its own operations.
- 1.7.4 Asset Management: This decision will have an impact on asset management as the buildings are assets of the Council and any

projects involving improving their environmental performance will require management.

SHARING INFORMATION ON GREENHOUSE GAS EMISSIONS FROM LOCAL AUTHORITY OWN ESTATE AND OPERATIONS

On 9 March 2011 Chris Huhne, Secretary of State for Energy and Climate Change, signed a Memorandum of Understanding (MOU) with the Local Government Group that recognised the pivotal role that local councils have in tackling climate change. The MOU, available at http://www.decc.gov.uk/en/content/cms/what_we_do/lc_uk/local/local.aspx outlines how my Department and the LG Group want to work together to help councils reduce greenhouse gas emissions

- on their own estate and operations;
- in their areas within local council control and influence; and
- through participating in national carbon reduction initiatives such as the Green Deal and renewable energy deployment.

To support the principles of the MOU, I would request that local councils measure and report their greenhouse gas emissions from their own estate and operations in accordance the with the joint DECC-Defra guidance that was published in September 2009 and available at http://www.defra.gov.uk/environment/economy/business-efficiency/reporting/ by the end of July each year.

My officials requested views from local councils in January on this new, less burdensome process, and there is broad support across the sector. I understand that many local councils asked for clarifications on the process and in response I will be publishing a Frequency Asked Questions document on the DECC website to help answer these. This is available at http://www.decc.gov.uk/en/content/cms/statistics/indicators/ni185/ni185.aspx

Data on area emissions and fuel poverty (formally covered by NI 186 and NI 187 respectively) will continue to be collated and modelled centrally by my department with no burden on councils.

APPENDIX B: WEATHER CORRECTED EMISSIONS

Emissions Summary

The Green House Gas (GHG) emissions for 2010/11 presented below include a weather correction calculation that is applied to the GHG emissions created from the consumption of natural gas, to take account of the weather experienced during the time period the data relates to. They are useful as a comparison to the absolute emissions data presented in the report as they indicate possible factors affecting the emissions data.

Figure 1: Comparison between Absolute and Weather Corrected Data




Figure 2: Progress against targets using Weather Corrected Data

1. Introduction

1.1 This is the first Green House Gas (GHG) emissions report from Maidstone Borough Council following the change to reporting requested by the Department of Energy and Climate Change in April 2011.

2. Local Authority Information

- 2.2 Kent has a two tier council system and Kent County Council (KCC) covers the whole of Kent (except Medway) and Maidstone is one of the 12 district councils in Kent.
- 2.3 Maidstone Borough Council's (MBC) office is located at Maidstone House, King Street, Maidstone, Kent, ME15 6JQ.

3. Reporting Period

- 3.1 This report relates to the following reporting periods;
 - 1st April 2009 to 31st March 2010; and,
 - 1st April 2010 to 31st March 2011

4. Approach

4.1 At the request of the Department for Energy and Climate Change (DECC) MBC has followed the Government's 'Guidance on how to measure and report you greenhouse gas emissions' which was published by DECC and the Department for Environment, Food and Rural Affairs (DEFRA) in September 2009.

5. Organisational Boundary

5.1 For the purposes of this report, MBC has included all the emissions sources which were previously included in its return to central Government. These sources were also all used (with the addition of water) when Maidstone Borough Council were part of the Local Authority Carbon Management Programme run by the Carbon Trust in 2010. This has been done in an attempt to make the new reporting method more meaningful and match more closely with the previously reported statistics, internal targets and Carbon Management Plan as a whole.

6. Operational Scopes and GHG Emissions

- 6.1 Scope 1, 2 and significant Scope 3 emissions have been measured.
- 6.2 A summary of the GHG Emissions from 2009/10 and 2010/11 compared to the baseline from 2008/09 can be found in Table 1 below.

7. Change in Emissions

- 7.1 Between 2008/09 and 2009/10 it can be seen that the emissions reduced quite significantly. This was predominately due to the fact that Maidstone Leisure Centre was partially closed for refurbishment during a large part of 2009/10 and was operating a much reduced service. Significant reductions were also seen in the emissions from the waste collection service and the Maidstone Borough Council Services fleet.
- 7.2 However, between 2009/10 and 2010/11, the emissions increased. Although in some cases this was expected, for example with a return to normal service at the Maidstone Leisure Centre, the total increase was higher than expected. Large increases in the emissions related to fuel usage at some of the main buildings including Maidstone House, The Hazlitt Arts Centre and Vinters Park Crematorium were the predominant cause of this increase. It is thought that the severe winter experienced had a significant impact on the fuel usage at a number of the buildings which caused the increase in GHG emissions seen. The reasons for the increase are currently being investigated.

8. Baseline Year

8.1 The baseline year is 2008/09. This was used as it aligns with the baseline for the Council's Carbon Management Plan; 2008/09 represents a year of full building usage and the data collected for that year is deemed to be more robust than for previous years.


9. Targets

- 9.1 As stated in the Carbon Management Plan, the Council's target is to reduce our CO₂e emissions from its activities by 20% from a 2008/09 baseline by March 2015. The MBC Carbon Management Plan outlines how it intends to both reduce carbon emissions by 20% over the prescribed period but also embed carbon management across the whole organisation.
- 9.2 These targets were calculated based on different methodology to that used to calculate the GHG Emissions in this report. These targets have been superimposed onto this methodology and the Council's progress against its internal targets is shown in both Table 4 and Graph 1 below.

9.3 The emissions in 2009/10 were 6.76% below the designated target for that year. However, the increase in emissions experienced in 2010/11 means that the Council was 5.08% over the stipulated target for that year. The reasons for the increase are currently being established with a view to identifying actions that will help to achieve the reduction in future years.
