- 1.4.1 There was a deficit of £2,701 on the receipts and payments account for 2011/12, however the Trust does continue to have a healthy bank balance with £7,740 in the accounts at  $31^{st}$  March 2012, and overall assets of £27,110 including the investment in the UST Combined Charitable Income Fund.
- 1.4.2 The most significant item of expenditure was a payment of £6,800 towards the purchase of a set of medals that had been owned by a grandfather, father and son from the same family. The cost was partially offset by a donation of £3,000 from the Queen's Own Buffs Association.

# 1. Queen's Own Royal West Kent Regiment Museum Trust Annual Report

- 1.1 Issue for Decision
- 1.1.1 To approve the 2011/12 annual report for the Queen's Own Royal West Kent Regiment Museum Trust for submission to the Charity Commission.
- 1.2 Recommendation of the Museums & Heritage Manager
- 1.2.1 It is recommended that the Committee approve the 2011/12 annual report for the Queen's Own Royal West Kent Regiment Museum Trust for submission to the Charity Commission.
- 1.3 Reasons for Recommendation
- 1.3.1 On 12 March 2007 the Charity Commission, in consultation with Maidstone Borough Council, created a new Scheme which appointed the Council as sole trustee of the Regimental Museum Charity. Ownership of the Trust's assets passed to the Council which now has responsibility for managing, curating and insuring the collection.
- 1.3.2 The old Regimental Trust has become an un-registered charity known as a Combined Fund. The Council has a Duty of Consultation to report once a year on matters relating to the management of the collection to a nominated representative of the Combined Fund (the Secretary of the Queen's Owns Buffs Association, based at the PWRR barracks in Canterbury). The Council must produce an annual report and accounts for the Charity Commission.
- 1.4 <u>Alternative Action and why not Recommended</u>

1.4.1	Any alternative course of action would not meet the requirements of the Charity Commission. This could undermine public confidence in the ability of the Council to manage the Queen's Own Royal West Kent Regiment Museum Trust.

#### **Queen's Own Royal West Kent Regiment Museum Trust**

#### **Annual Report 2011-12**

- 1. The Queen's Own Buffs Regimental Association remain very supportive of the regimental museum. Over the last year with the support of Council staff they have organized three events held in Maidstone Museum for their members.
- 2. Discussions with the Association concerning the development of a programme of externally funded improvements to the regimental museum have begun. Consultation with other partners and with visitors will begin early in 2013.
- 3. The Association has submitted a planning application (MA/12/2008) for the erection of a bronze statue of a soldier which is intended to commemorate the Royal West Kent Regiment. They propose that the statue be located in the front courtyard of Maidstone Museum opposite the Gurkha statue that was placed there in 2009.
- 4. Media interest in the Regimental Museum remains high. Articles and stories relating to the regimental museum regularly appear in the local press and on TV.
- 5. During the year 20 individual donors made donations to the regimental collection. These include;

- Medals, cigarette case, watch guard, camera and purse (containing lucky black cat and "Ypres" ring) of 2Lt Percy Stevens, 7thBn RWK
- Silver cigar box of Capt C E Stern, 4<sup>th</sup> Bn RWK
- Military Cross, 1914-15 Star, 1914-19 War Medal, Victory Medal of Capt E Fulcher
- 1914-19 War Medal and Victory Medal of Albert Agnew
- 1939-45 Star, Africa Star, Italy Star, Defence Medal, 1939-45
   War Medal of George Wilson
- Medals (Territorial Medal, 1939-45 War Medal with oak leaf clasp, Defence Medal, Burma Star, Africa Star with 8<sup>th</sup> Army clasp, 1939-45 Star), miniatures, diary, photographs and kukri of Major Shaw, RWK
- 1914-19 War Medal + Victory medal of Pte W Dutton, RWK
- Defence Medal, 1939-45 War Medal, documentation, photo album with RWK embroidered crest of Pte F W H Joyce, RWK (donor lives in New Zealand)
- Autograph album relating to 8<sup>th</sup> Bn, RWK
- 6. A short audio-visual presentation recording the memories of eight veterans of the Battle of Kohima (1944) has been prepared. It will soon be installed in the Museum for visitors to view.
- 7. An interactive computer display has been installed in the museum which provides information about the medals on display. This was funded by the Museum Trust.
- 8. Looking ahead, the regimental museum will be the focus of much interest when we commemorate the 100<sup>th</sup> anniversary of the Great War in the summer of 2014. Work has already started on developing a programme of activities for the anniversary.
