We went into the shop and got some sweets, then went to where the alcohol was, picked up a WKO blue, went to the till, there was another boy/man in front, I then asked for 10 Marlborough light, he said the amount, I put what I was purchasing down and payed for it. I payed about £6. The man who served me was roughly six foot, Turkish/foreign looking and around 35/40 years old. We left the shop around 8:10, we went back to the car and gave the alcohol and cigarettes to Jill Powell. I gave the cigarettes to Jill Powell. [REDACTED]
